## 2024 ACTIVITES

- ## Progress continues on the Fremont Municipal Inland Port Authority!



GFDC continues to market the Inland Port as an opportunity for growth new and existing businesses. This is a long term project and critical planning continues. As part of the planning, GFDC worked with engineering firms to plan for rail and develop concepts to help us understand highest and best use of land. **We worked with the Port Authority to secure a \$2M grant for additional engineering and potentially an initial phase of construction for Morningside Road.** Additionally, GFDC continues to work through the Rural Projects Act Grant to secure some critical pieces of property in the Port Authority and partner with existing land owners. Why does this site control matter if there are no businesses ready to locate just yet? We're hoping to set our community up for opportunity for decades to come and site control is an important piece of this puzzle. It provides more certainty for potential investors, helps with infrastructure planning, ensures more efficient and safe land use, and helps mitigate risk. Good planning and site control serve as the foundation for successful and sustainable economic development, creating an environment conducive to growth, investment, and job creation!
